President's Advisory Committee

The President's Scientific Advisory Committee, according to an announcement made on November 29th, has been transferred from the Office of Defense Mobilization to the White House. At the same time the following new members were named to the committee: Lieut. Gen. James H. Doolittle, retired; R. F. Bacher, professor of physics at the California Institute of Technology; E. M. Purcell, professor of physics at Harvard University; Herbert York, director of the Livermore Laboratory of the University of California; and George B. The committee, which is headed by I. I. Rabi, professor of physics at Columbia University, also includes among its members James R. Killian, president of the Massachusetts Institute of Technology, who is now on leave as the President's newly appointed Special Assistant for Science and Technology. It has been indicated that the transfer of the committee to the Executive office was designed to consolidate further the function of defining scientific policy within the White House itself
