APS LAUNCHES NEWSLETTER TO PROVIDE NEWS AND OPINION

Beginning in January 1990, subscribers to the Bulletin of The American Physical Society will be receiving a bonus: News of The American Physical Society, a monthly newsletter devoted to coverage of the activities of APS and its various divisions, topical groups and committees. In addition to "hard" news items of basic interest to members of the society-APS election results, committee reports and the like-News editor Robert Strauss promises coverage of broad issues that concern all APS members. "Items such as the impending change in the governance of APS and the creation of the Physics Planning Committee," says Strauss, "point up the need for a forum to which members can turn to find out what's going on in the organization and to express their opinions." A basic aim of the newsletter, Strauss adds, is to unify the various subgroups of APS, whose members often are unaware of the activities of their colleagues in other divisions, topical groups and committees. In short, News of The American Physical Society will allow members to glean items of interest quickly from reports

on the activities of the society.

A Cornell graduate, Strauss comes to APS from a weekly publication in the consumer electronics industry and, before that, a peer-reviewed medical journal. With his experience in journalism and technical writing, Strauss is confident that he can make News of The American Physical Society a real asset to all APS members.

Open Forum on Cold Fusion at APS Meeting

In light of the stir brought on by Martin Fleischmann and Stanley Pons (see PHYSICS TODAY, June, page 17), APS Executive Secretary W. W. Havens Jr asked E. F. Redish of the University of Maryland, College Park, to organize a postdeadline session on cold fusion for the Baltimore meeting in cooperation with the division of nuclear physics. Redish heads the topical group on few-body systems and multiparticle dynamics, which had already organized a regular session on muon catalyzed fusion with Steven Jones (Brigham Young University) as an invited speaker.

Notice of the special session was broadcast via electronic mail and fax machine in the ten days before the meeting, and contributed papers were requested. By the deadline (seven hours before the start of the 1 May session) a total of 41 abstracts had been received.

Approximately 1800 people attended the session, and a second session was held on 2 May. A complete set of invited and contributed abstracts from both sessions will be published in the July–August *Bulletin of The American Physical Society*.
