### ASEE Mathematics Division

The Mathematics Division of the American Society for Engineering Education met on June 20-24, 1955, at Pennsylvania State University. Four well-attended sessions of the Division were held. The following new officers of the Division were elected at the annual business meeting: chairman, Haim Reingold, Illinois Institute of Technology; secretary, William E. Restemeyer, University of Cincinnati; director, Cletus O. Oakley, Haverford College. Richard S. Burington, Bureau of Ordnance, Navy Department, and Carroll V. Newsom, executive vice chancellor, New York University, will continue to serve as directors, and R. S. Burington was elected as council member of ASEE. The next annual meeting of the ASEE Mathematics Division will be held in June 1956 at Iowa State College. For further information write to Professor W. E. Restemeyer, University of Cincinnati.

### Calorimetry

The tenth annual Calorimetry Conference is scheduled to meet in Minneapolis at the University of Minnesota, September 16-17. The purpose of the conference, as first founded and organized by the late Hugh M. Huffman, formerly director of thermodynamic research at the U. S. Bureau of Mines, is "to promote better calorimetry by informal discussion of mutual problems, by interchanging ideas, and by presentation of new experimental techniques of calorimetry". The conference will be devoted in part to such topics as very low temperature calorimetry, liquid helium calorimetry, high and low adiabatic calorimetry, measurements of stored energy in solids, high precision bomb calorimetry, measurements of heats of solutions and heats of precipitation both for liquid-solid and solid-solid temperatures, symbols and terminology, standard calorimetric samples, and promotion of better instrumentation and publication policies relevant to thermodynamics data. The chairman of the 1955 meeting is Warren DeSorbo (General Electric Co.) and the program chairman is Edgar F. Westrum, Jr. (University of Michigan). Members of the board of directors in addition to DeSorbo and Westrum are E. J. Prosen (National Bureau of Standards), J. W. Stout (University of Chicago), Guy Waddington (Bureau of Mines), and D. R. Stull (Dow Chemical Company).
